

**MEMORANDUM OF UNDERSTANDING
BETWEEN
MAHASARAKHAM UNIVERSITY,
THAILAND
AND
HUE UNIVERSITY,
VIETNAM**



This memorandum sets out the terms and conditions under which the two institutions have agreed to work together to promote academic and research co-operation as well as the exchange of staff, students and information. The spirit of this initiative is intended to develop a closer understanding, greater co-operation and a durable friendship between the two universities, as well as co-operation in the delivery of nominated degree programs.

In pursuance of this aim, the two entities, **MAHASARAKHAM UNIVERSITY** and **HUE UNIVERSITY**, have agreed to the following:

TERMS AND CONDITIONS

1. The Memorandum of Understanding (MoU) essentially sets out the general nature of the co-operative agreement between **MAHASARAKHAM UNIVERSITY** and **HUE UNIVERSITY**. It is not intended that the agreement shall give rise to any legal rights or obligations between the two institutions.
2. Neither party assumes any financial obligations arising from the MoU except as mutually agreed under separate schedules jointly established from time to time.
3. Specific projects encompassed by this MoU will be agreed upon by both parties.

THE GOAL

The intended goal of this MoU is to develop and maintain an ongoing relationship between the two institutions. The relationship will provide opportunities for institution members (academic, administrative and professional staff) as well as students to participate actively in the educational programs of the two institutions.

SCOPE OF ACTIVITIES

Activities may include, but are not limited to, the following:

1. Exchange of undergraduate and/or graduate students
2. Exchange of faculty members and/or staff
3. Joint research activities and publications
4. Participation in seminars and academic meetings
5. Exchange of research materials

COMMENCEMENT AND DURATION OF THIS AGREEMENT

This memorandum shall enter into force on the date of signature and shall remain in force, unless either party shall give the other at least 6 months' prior notice of termination in writing. It is further agreed that any decision to allow this MoU to lapse will take into consideration the time needed for completion of any projects under way or any exchange visitors completing courses.

IN WITNESS WHEREOF, the undersigned, being duly authorised by their respective universities, signed this memorandum.


